AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS OF CANTERBURY SUBDIVISION

THIS AMENDMENT to Declaration of Covenants, Conditions and Restrictions of Canterbury Subdivision is made on the date hereinafter set forth by the undersigned record owners of the lots within Canterbury Subdivision (hereinafter referred to as "Owners").

WHEREAS, Cambridge Park L.L.C., an Idaho limited liability company (hereinafter referred to as "Declarant") heretofore filed of record the Declaration of Covenants, Conditions, and Restrictions of Canterbury Subdivision No. 1, which declaration was recorded on September 27, 1996, as Instrument No. 96080707, Records of Ada County, Idaho (hereinafter the "Declaration");

WHEREAS, pursuant to Article XIV, Section 3 of the Declaration, amendment of any provision thereof requires the consent of the members entitled to cast not less than sixty-six and two-thirds (66 2/3 %) percent of the votes of membership of the Homeowners Association described in Article III of the Declaration; and

WHEREAS, the undersigned owners comprise at least sixty six and two-thirds (66 2/3%) percent of the percentage voting requirement in order to amend said Declaration;

NOW, THEREFORE, the Original Covenants shall be and is hereby amended as follows:

Article VII, Section B of the Declaration is hereby amended in its entirety to read

as follows:

amendment to declaration of covenants, conditions, and restrictions of canterbury subdivision $\cdot 1$

B. <u>ANIMALS</u>: An Owner shall be allowed to keep and maintain a total of three (3) dogs and/or cats in any combination on the premises. In no event shall an Owner be allowed to have or maintain a kennel (hobby or commercial,) as defined by the Ada County Dog Control Ordinance. In addition to a combination of three (3) dogs and/or cats an Owner may keep and maintain a total of two (2) large animals in any combination, provided that such animals are not kept, maintained or bred for any commercial purpose and are kept and maintained in such manner as not to constitute a nuisance or otherwise be offensive to Owners. Large animals shall be limited to Horses, Cows, Llamas, Sheep and Goats. No other large animals shall be maintained or kept by an Owner except as set forth above.

Any animals not on an Owner's Lot must be accompanied by the Owner or other responsible person and must be on a leash or other appropriate tether, and the Owner or custodian of the animal shall be responsible for the immediate cleanup of the animals droppings. Each Owner shall be further responsible for any damage caused by any such Owner's animals. No kennel or other area intended to restrain or enclose animals shall be constructed without the approval of the Architectural Control Committee and, if approved, shall not be located on the Lot in such a fashion as to create a nuisance for any adjacent Lot Owner and shall at all times be kept in a clean and odor free condition.

Except as amended herein, the Original Covenants shall remain in full force and effect with no other change or modifications.
